PART "A"--WAIVER & RELEASE FROM LIABILITY

By my printed name and signature below, my participation or entrance into the event or admittance to any area wherein admittance to the general public is prohibited, I agree to release and hold harmless for any accidents, injury or illness that may occur or may be alleged in the future to of have occurred on the above date as a result of either my, my minor child's or my legal ward's participation in, assistance in, or as a spectator during the course of the above named event and related or unrelated activity being conducted by above named sponsor or event sponsor.

To the best of my knowledge, I am not aware of any physical disability or health-related reasons or problems which would preclude or restrict my, my child's or my legal ward's participation in this activity. I am fully aware of the risks and hazards connected with the above named event and that there may be other unknown risks and I hereby elect to participate in, or allow my child's or my legal ward's voluntary participation in said activity, knowing that the activity may be hazardous to me, my minor child, my legal ward or my property. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury, including death, that may be sustained by me, my minor child or my legal ward, or any loss or damage to property owned by me, as a result of being engaged in the above named event and related or unrelated activity, however caused in whole or in part by the negligence of the above named sponsor.

Further it shall be my responsibility to immediately notify the above named sponsor of a situation or condition which is perceived to be unsafe or a danger.

Said County Court of Common Pleas shall have exclusive jurisdiction and venue to resolve any such claims.
